4 First Aid Measures

Inhalation:

The Australian Acceptable Daily Intake (ADI) for clofentezine for a human is 0.02 mg/kg/day, set for the public for daily, lifetime exposure. This is based on the NOAEL of 2 mg/kg/day, the level determined to show no effects during long term exposure for the most sensitive indicators and the most sensitive species.

The Australian ADI for Abamectin (sum of abamectin + 8,9-Z isomer) for a human is 0.001 mg/kg/day, set for the public for daily, lifetime exposure. This is based on the NOAEL of 0.1 mg/kg/day. (Ref: Australian Pesticides and Veterinary Medicines Authority, 'Acceptable Daily Intakes for Agricultural and Veterinary Chemicals', 2020).
