

Skin Contact:

6 Accidental Release Measures

Environmental Precautions:

In the event of a major spill, prevent spillage from entering drains or water courses.

Methods and Materials for Containment and Cleaning Up:

Stop leak if safe to do so and absorb spill with sand, earth, vermiculite or some other absorbent material. Collect the spilled material and place into a suitable container for disposal. Use only non-sparking tools. Wash spill areas with water, preventing runoff from entering drains.

Precautions for Safe Handling:
