Some naturally occurring individual fungi resistant to the product and other Group 2 fungicides may exist through normal genetic variability in any fungal population. The resistant individuals can eventually dominate the fungal population if these fungicides are used repeatedly. These resistant fungi will not be controlled by this VOLTAR 500 SC or other Group 2 fungicides, thus resulting in a reduction in efficacy and possible yield loss. Since the occurrence of resistant fungi is difficult to detect prior to use. Indigo Specialty Products Pty Ltd accepts no liability for any losses that may result from the failure of this product to control resistant fungi.

#### EXPORT OF TREATED PRODUCE

Growers should note that MRLs or import tolerances may not exist in all markets for produce treated with VOLTAR 500 SC. If you are growing produce for export, please check with Indigo Specialty Products Pty Ltd for the latest information on MRLs and import tolerances BEFORE using VOLTAR 500 SC.

#### MIXING

Note: VOLTAR 500 SC may be unstable in conditions where the pH is 7 or higher. It is therefore essential to check the pH of the spray solution before adding VOLTAR 500 SC. A suitable registered buffering agent may have to be added to bring pH down below 7. Add half the required water volume to the sprav tank or vat with the agitation mechanism operating. Add the required volume of this product and then add additional water to the volume required

#### TURF NUTRITION

This product acts very rapidly and where the turf is of a low nutritional status, a slight yellowing may be seen. This will be corrected by nitrogenous fertilizer application. Where possible, it is recommended that the fertilizer program should precede the fungicide application.

#### APPLICATION

Good disease control requires even, thorough coverage of the target area. Application should be made using appropriate spray equipment and sufficient water to provide adequate penetration and coverage Equipment settings and water volume may need to vary, depending on the growth stage of the crop.

#### Tree and Vine Crops Dilute Spraving

Use a sprayer designed to apply high spray volumes, up to the point of run-off and matched to the crop being sprayed. Set up and operate the sprayer to achieve even coverage throughout the crop canopy. Apply sufficient spray solution to cover the crop to the point of run-off. Avoid excessive run-off. The required spray volume to achieve point of run-off may be determined by applying different test volumes, using different settings on the sprayer, from industry guidelines or expert advice. Add the amount of product specified in the Directions For Use table for each 100 L of water. Spray to the point of run-off. The required dilute spray volume to achieve point of run-off will change and the sprayer set up and operation may also need to be changed, as the crop grows.

#### Concentrate Spraying

Use a spraver designed and set up for the concentrate spraving (that is a spraver which applies spray volumes less than those required to reach the point of run-off) and matched to the crop being spraved. Set up and operate the spraver to achieve even coverage throughout the crop canopy using your chosen water volume. Determine an appropriate dilute spray volume (See Dilute Spraying above) for the crop canopy. This is needed to calculate the concentrate mixing rate. The mixing rate for concentrate can then be calculated in the following way: FXAMPLE ONLY

1. Dilute spray volume as determined above: For example 1500 L/ha.

2 Your chosen concentrate spray volume: For example 500 L/ha

3. The concentration factor in this example is: 3x (ie 1500 L  $\div$  500 L = 3).

4. If the dilute label rate is 10 mL/100 L, then the concentrate rate becomes 3 x10, that is 30 mL/100 L of concentrate spraving.

The chosen sprav volume, amount of product per 100 L of water, and the spraver set up and operation may need to be changed as the crop grows.

For further information on concentrate spraving, users are advised to consult relevant industry guidelines, undertake appropriate competency training and follow industry Best Practices.

#### COMPATIBILITY

VOLTAR 500 SC is compatible with the following products: Aliette\* WG, Bugmaster\* Flowable, calcium chloride, chlorpyrifos 500 EC, copper oxychloride, dimethoate, endosulfan, maldison, mancozeb, metalaxyl and methomyl .

When tank mixing products the order of mixing is determined by formulation type. As a guide the following mixing sequence is recommended.

- 1. Wettable powders
- 2. Suspension concentrates
- 3. Water Dispersible Granules
- 4. Suspo-emulsions (eg. VOLTAR 500 SC)
- 5. Soluble powders
- 6. Solutions
- 7. Emulsifiable concentrates
- 8. Soluble concentrates
- 9. Wetting agents and oils

With any mixture, thoroughly agitate immediately before applying. It is not recommended to mix this product with more than one of the above chemicals in the tank. The use of a surfactant or spray oil is not recommended with VOLTAR 500 SC as it may result in crop damage to sensitive plants. DO NOT mix with fertilisers. Note: Mixing VOLTAR 500 SC with Aliette WG may result in some settling out. As formulations of other manufacturer's products are beyond the control of Indigo Specialty Products Pty Ltd, all mixtures should be tested prior to mixing commercial quantities.
