#### **4 First Aid Measures**

## Inhalation:

If inhaled, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Seek medical attention if breathing problems develop.

#### Skin Contact

In case of skin contact, immediately remove contaminated clothing and wash affected areas with water and soap. Seek medical attention if symptoms occur.

#### Eye Contact:

In case of eye contact, rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Seek medical attention.

## **5 Fire Fighting Measures**

#### Suitable Extinguishing Media:

Carbon dioxide, dry chemical, water spray, universal-type foam. Use fire extinguishing media suitable to surrounding conditions.

## **Specific Hazards Arising from the Chemical:**

Hazardous combustion products include oxides of carbon and nitrogen, and unidentified organic products. Due to the water content, this product is not expected to be flammable but may burn or decompose in a fire. Containers close to fire should be removed if safe to do so. Use water spray to cool fire exposed containers. Minimise firefighting run-off from entering drains or water courses.

#### **Special Protective Equipment and Precautions for Fire Fighters:**

When fighting a major fire wear self-contained breathing apparatus and protective equipment.

#### 6 Accidental Release Measures

#### Personal Precautions, Protective Equipment and Emergency Procedures:

Wear approved respiratory protection, chemical resistant gloves, protective clothing, and safety boots. Evacuate all non-essential personnel from affected area according to the local emergency plan. Do not breathe vapours. Ensure adequate ventilation. Extinguish all sources of ignition. Avoid sparks and open flames. No smoking.

#### **Environmental Precautions:**

In the event of a major spill, prevent spillage from entering drains or water courses. Report spills to appropriate authorities if required.

#### Methods and Materials for Containment and Cleaning Up:

Wipe up small spills with a cloth. Stop leak if safe to do so and recover free product. Absorb remainder of spill with sand, earth, vermiculite or some other absorbent material. Collect the spilled material and place into a suitable container for disposal. Clean residual contamination with hot water and detergent.

## 7 Handling and Storage

## Precautions for Safe Handling:

Use of safe work practices are recommended to avoid eye or skin contact and inhalation of vapours. Use only outdoors or in a well-ventilated area.

Food, beverages, and tobacco products should not be stored or consumed where this material is in use. Always wash hands before smoking, eating, drinking, or using the toilet. Wash contaminated clothing and other protective equipment before storage or re-use.

#### **Conditions for Safe Storage:**

Store in a cool, dry and well-ventilated area, protected from light. Keep container tightly closed when not in use. Protect from extreme heat, sparks, open flames, and all other sources of ignition. Keep away from strong oxidising agents, strong acids and strong alkalis.
