Foliar - Dilute 1 gallon with 100 gallon of water to cover leaves.	Apply every 1-3 months Apply as needed or consult your Mirimichi Green representative
Container Plants	Dilute 2.5-5 ounces per gallon of water.	Apply every 2-3 weeks
Deep Root Injection	Inject 1 gallon per 1-inch diameter of trunk with dilute solution. 1:50-1:100 ratio (drench rate).	Apply 1-3 months
Hydroponics	Dilute 5 milliliters per gallon of water or 17 ounces per 100 gallons of water.	Apply at every feed
