#### **DIRECTIONS FOR USE**

#### **USE RATES**

0.25%–0.50% v/v (2–4 pints) of Spray-Put<sup>TM</sup> per 100 gallons of spray solution.

#### MIXING

Fill the spray tank with at least 50% of the desired finished carrier volume. **Do not** pre-mix Spray-Put<sup>™</sup> in a mixing vessel or inductor. While the carrier is agitating, add tank mix ingredients in the following order:

1. Compatibility agent and/or antifoam, if needed

- 2. AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants
- 3. Dry soluble and suspension fertilizers / micronutrients

- 4. Liquid drift retardants and flowable formulations (F & FL)
- Liquid concentrates, suspension concentrates, microencapsulated and capsule suspension (LC, SC, ME, CS)
- 6. Emulsifiable concentrates (E, EL or EC)
- 7. Solutions and soluble liquids (S or SL)
- 8. Liquid micronutrients and fertilizers
- Water conditioners and other adjuvants (COC, HSOC, MSO, NIS)
- 10. Finish filling to desired spray volume level and continue agitation
